Denmark is divided into five regions. The regions are in charge of running hospitals and (through collective agreements) managing the general practitioner system. The local governmentis in charge of providing prevention and healthcare services to the public.

Hospital treatment is free of charge for residents in any region of Denmark, and emergency treatment is available to any person in need.

ADDITIONAL INFORMATION:

- A salary for a doctor is divided into 2 parts a fixed amount and supplements. The average salary for medical specialists in Denmark is about 120.000 euro/year before tax. (plus 18 % in Pension). When you are employed in Denmark, a large amount of the pay and employment terms will be subject to a collective wage agreement. This is an umbrella agreement signed between employee representatives and employer representatives. There are agreements for Medical Specialists, Consultants and registrars.
- Language training will be a part of the contract for all job offers, so you get the salary from the first day in Denmark, but the first 2-3 month you are on fulltime language training. After 2-3 months, you start to work on the hospital 1 or 2 days a week until you have past the last language exam which normally takes 1- 1,5 year. Your family can take part in the language training for free also. Sometimes the salary for the first 3 months will be a little lower about 7000 Euro/month while you are on fulltime language training. You will still be able to support your family in Denmark for this amount.
- Qualified candidates will be interviewed via Skype and will be invited to Denmark with the family for further discussions about the position, The hospital will offer you a relocation package - help for finding accommodation, help finding schools for children and most other relevant help when you move to another country. There will also be help for a partner to find a job.
- Language skills required is a good level of English or German no Danish.
- It is a condition that you can obtain Danish authorization. Due to the authorization procedure, it is an advantage if you have completed your medical education in an EU/EEA country and are an EU/EEA citizen. - Regarding EURES programs of financial support to travel for job interviews or relocation to Denmark, eligible candidates will be informed about them from EURES Denmark.
- All contracts are permanent, but there might be a possibility to cancel the contract if the applicants are not able to learn the language within a certain time limit. Nevertheless, there is no previous experience of this happening before
- On all job offers, there are contact details where the applicant can ask questions about the job offer and conditions.
