

**Arrangement for Technical Collaboration
between the Consorcio Parque de las Ciencias
and the Korea Occupational Safety and Health Agency**

The Consorcio Parque de las Ciencias, with a principal place at Avenida de la Ciencia s/n 18006 Granada, España, and the Korea Occupational Safety and Health Agency (hereinafter referred to as “KOSHA”) with a principal place at 400 Jongga-ro, Jung-gu, 44429 Ulsan, Republic of Korea, decide to extend the arrangement on technical collaboration in the field of occupational safety and health as follows.

1. Purpose

- 1.1. The main purpose of this arrangement is to support enhancing capability of the occupational safety and health and contribute to promoting safety and health of workers at the workplaces in both countries by establishing a cooperative relationship between Consorcio Parque de las Ciencias and KOSHA in the field of occupational safety and health.

2. Scope

- 2.1. The scope of collaboration includes exchange of experts for sharing knowledge and experience and providing consultation, and exchange of technical information and materials, etc. on prevention culture of occupational safety and health.
- 2.2. Consorcio Parque de las Ciencias and KOSHA, upon mutual consent, may change the scope of collaboration.



3. Implementation

- 3.1. Consorcio Parque de las Ciencias and KOSHA will actively collaborate within available resources for successful collaboration.
- 3.2. Any other form of collaboration that is not stipulated in the scope of this arrangement will be implemented by mutual consent.
- 3.3. Consorcio Parque de las Ciencias and KOSHA may exchange publications and materials concerning occupational safety and health free of charge or at a reasonable price when such a need arises.
- 3.4. An annual implementation plan will be made through mutual consultation prior to commencement of its implementation.

4. Expenses

- 4.1. The expenses for mutual collaboration under this arrangement will be considered and apportioned on a case-by-case basis upon mutual consent.

5. Liaison

- 5.1. Consorcio Parque de las Ciencias and KOSHA will respectively designate a contact point for communication and coordination of the collaboration within the scope of this arrangement.
- 5.2. If necessary, Consorcio Parque de las Ciencias and KOSHA may have a meeting with each other to monitor and evaluate the progress of this collaboration.

6. Period

- 6.1. The arrangement shall take effect upon signing hereof and shall be valid for four years and may be discontinued by Consorcio Parque de las Ciencias or by KOSHA by written notice to the other participant. The implementation period may be extended by mutual consent.
