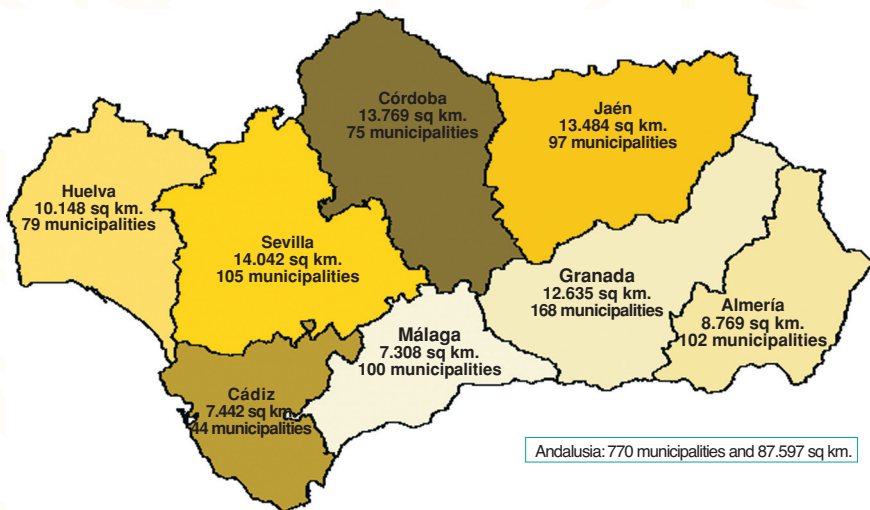

1.1. Total area and number of municipalities by province. 2004



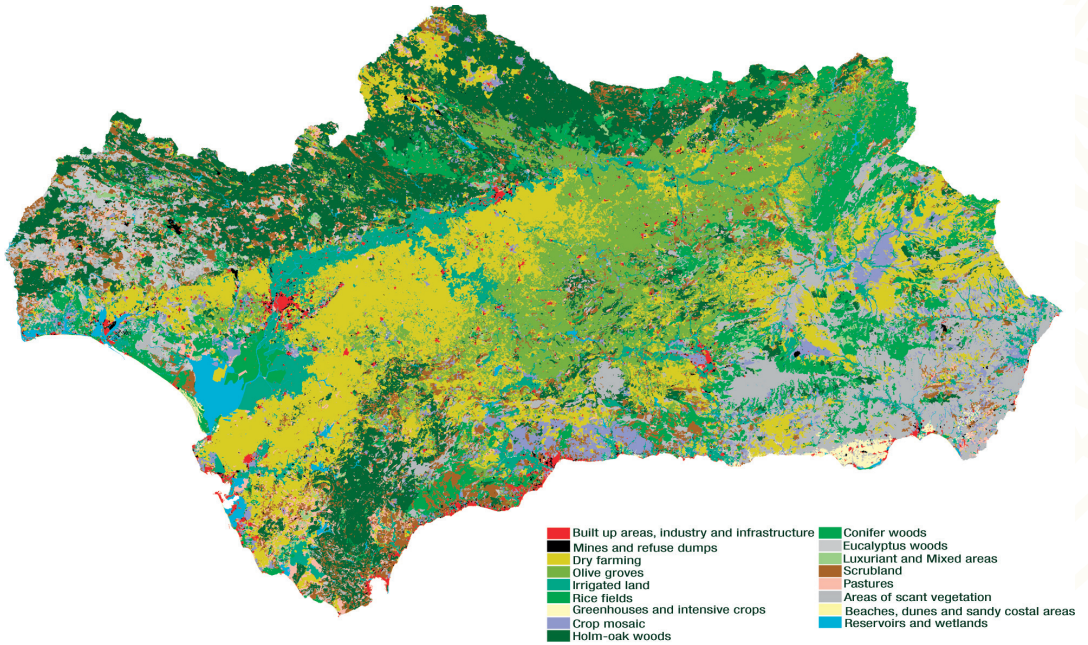

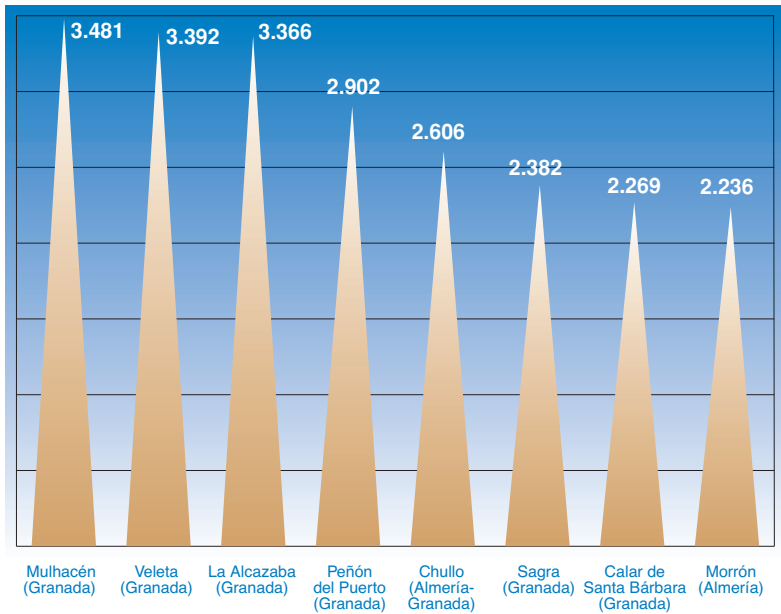

evolution. To this end the land cover database obtained from the digital satellite imagery of the Autonomous Community and its subsequent analysis is exploited statistically at different spatial levels.

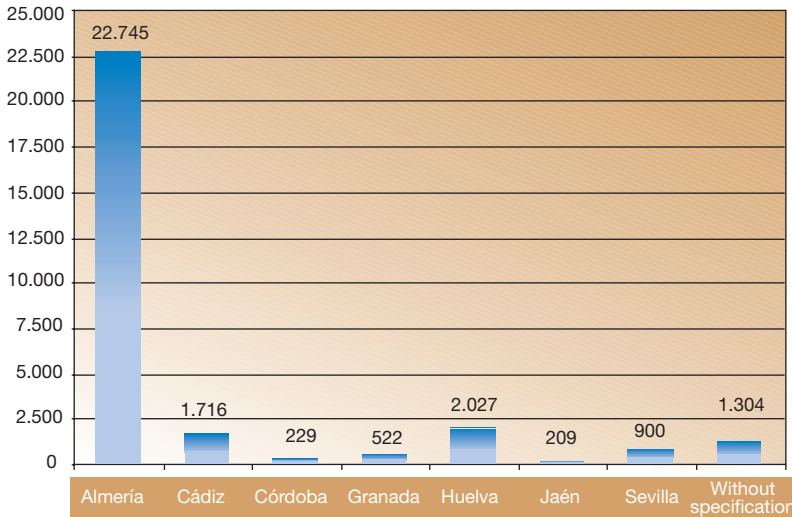

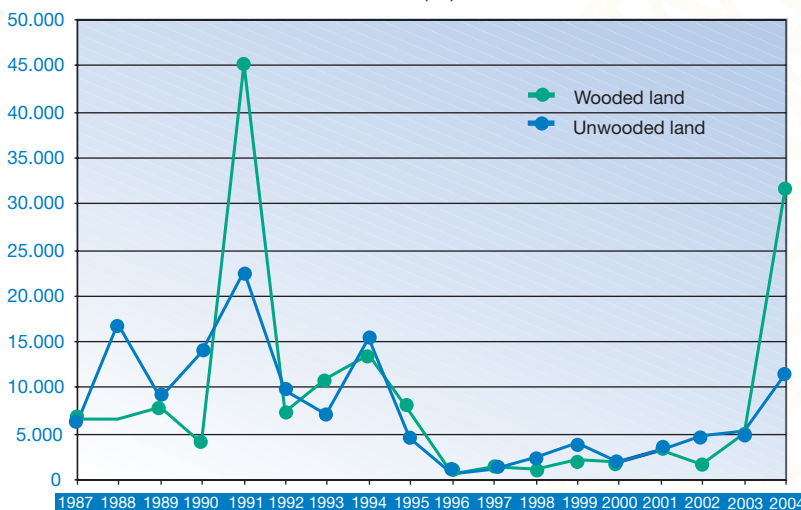

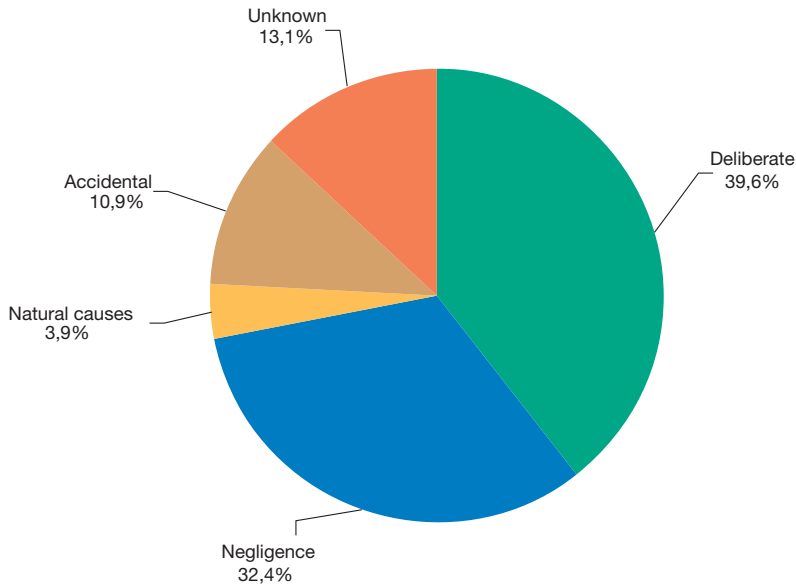
1.7. Evolution of the area set afire according to type in Andalusia. 1987-2004 (ha)

Forest fire statistics in Andalusia. Regional Government Ministry of the Environment. The goal of this activity is to respond to the Administration and forestry sector's information requirements on the area affected by forest fires in each province and in Andalusia as a whole. For that reason, the following variables are analysed: number of fire incidents, potential fire situations and forest fires, areas affected by the fire; causes of fires; means and resources assigned to the fire; duration; time of outset; etc.

* Unacceptable levels of atmospheric pollutants are considered all those classified as bad or very bad according to the 1073/2002 Royal Decree criterion. They are:

SO₂: to calculate the index the 24 hours limit value (daily average over 125 µg/m³) set out in the Directive 1999/30 is considered. However if the 1-h limit value (470 µg/m³) laid down in the same directive is exceeded, the air quality will be considered "bad" and "very bad" when the alert threshold (value for 3 consecutive hours higher than 500 µg/m³) is exceeded

Suspended particles: to calculate the index the 24 hours limit value (daily average over 70 µg/m³) set out in the Directive 1999/30 is considered.

NO₂: to calculate the index the hourly limit value (290 µg/m³) set out in the Directive 1999/30 is considered. When the alert threshold (value for 3 consecutive hours higher than 400 µg/m³) is exceeded the air quality will be considered "very bad"

Ozone: to calculate the index the objective value for the protection of health laid down by the new Directive (eight hour value of 20 µg/m³) is considered.

When the value of information to the public (hourly value of 180 µg/m³) is exceeded the air quality will be considered "bad" and "very bad" when the alert threshold for the population (hourly value of 240 µg/m³) is exceeded.

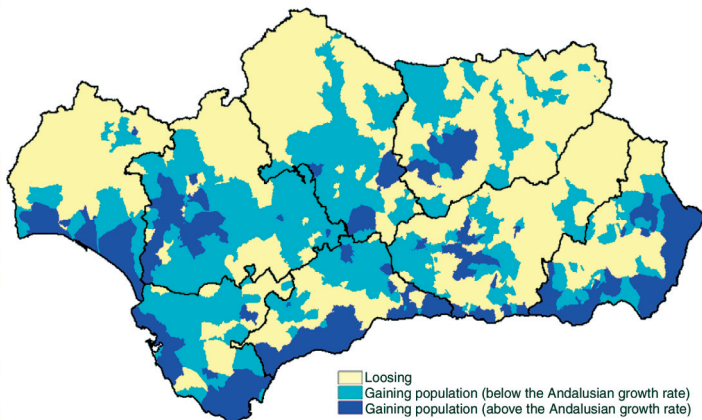

Andalusian Population Census 2001. The Population Census is a statistical source of doubtless interest for the demographic knowledge of the Spanish population and the Andalusian in particular. The census, taken every ten years, is aimed at determining the number of inhabitants in each territorial area and knowing specific demographic,

cultural, economic and social features about them as outstanding goals. It furnishes a structural representation of the population that serves the Administration and numerous users as a basis for decision-making and research.

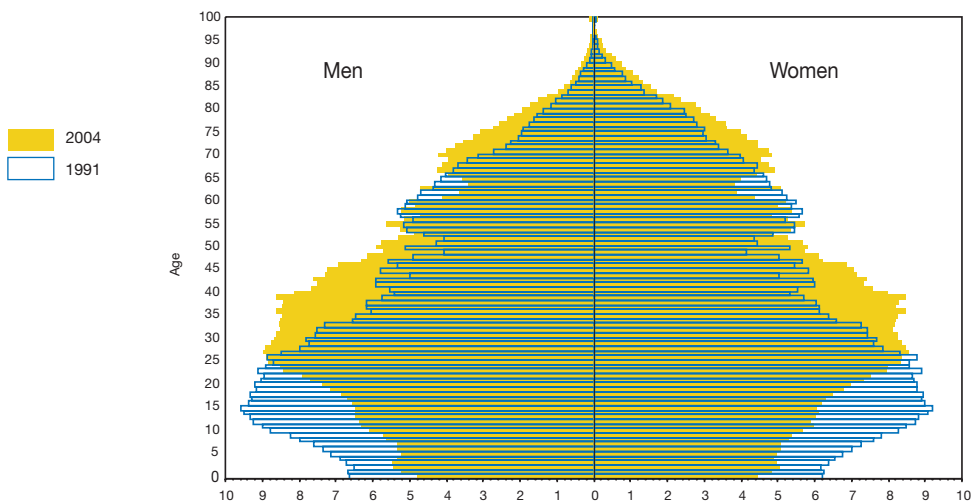

The last census was taken in 2001 and its first statistical results were available in 2002. The detailed final data were published in February 2004. In Andalusia, the Institute of

Statistics of Andalusia (IEA) in collaboration with the National Institute of Statistics (INE) has participated in the elaboration of this census, as in the previous one of 1991.

Municipal Register of Inhabitants (PMH). The PMH is the roll of inhabitants of each municipality, which includes name, surnames and address and must be permanently updated. It is, therefore, an administrative register, but also has a statistical use as it provides a population count and information on important demographic variables, such as gender and age.

The PMH was corrected annually (these were the so called census corrections) and it was completely renewed

every five years (the so called census renewals) until the Law 4/19961 of 10th of January came into effect, amending the law 7/1985 of 2nd of April, regulating the Bases of the Local Regime in connection with the Municipal Register.

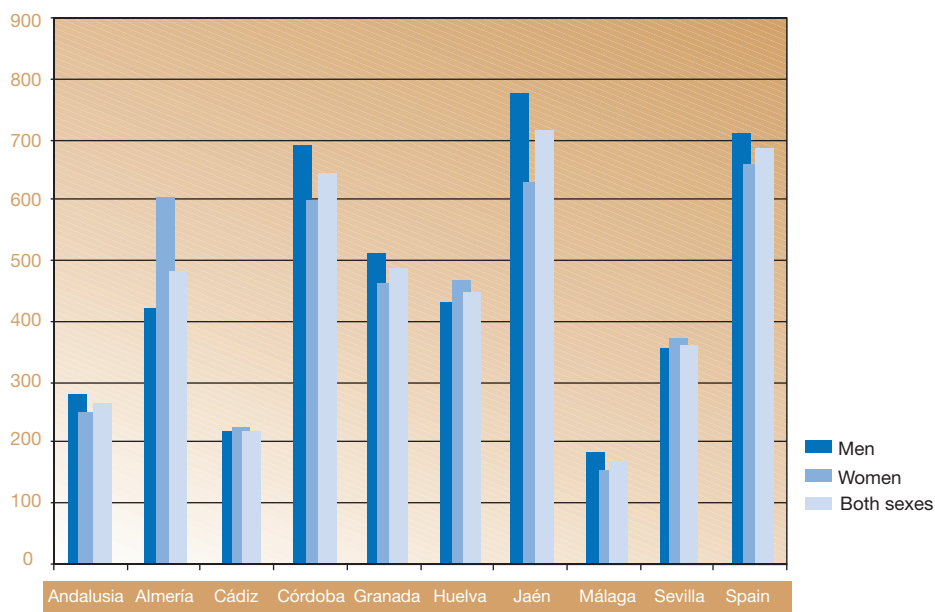
From this law, a continuous register through the coordination and collation of the registers of all the municipalities was implemented; in this way, the census revisions are obtained on 1st of January of every year. The organism responsible for this task is the INE.

Vital Statistics (MNP). Vital statistics refers basically to births, marriages and deaths that have taken place in the Spanish territory. It is a statistical operation aimed at improving information on population flows. The diverse vital statistics gather data from statistical bulletins filled in on registering these demographic events in the Civil Register.

The classification criteria of the three demographic events that integrate the vital statistics are multiple. Thus, births are tabulated according to gender, birthplace, parents' age, etc. Likewise, deaths are classified according to age, place and cause of death. Finally, for marriages, age, civil state, profession of the spouses etc, are taken into account.

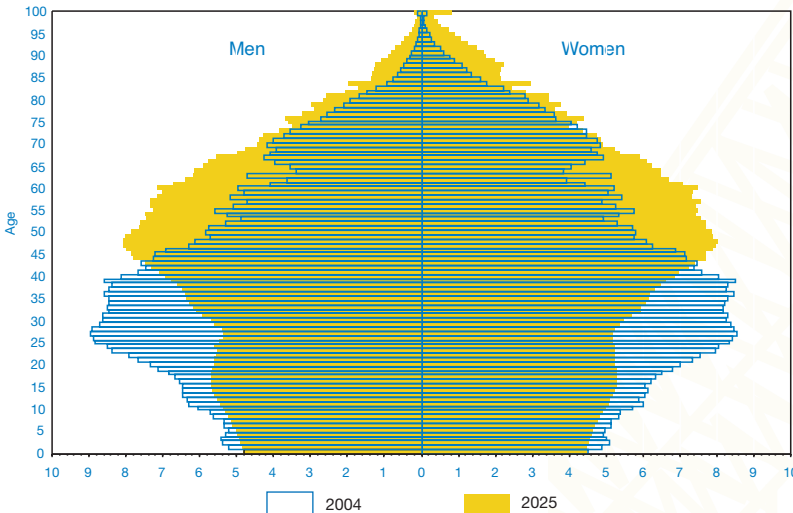

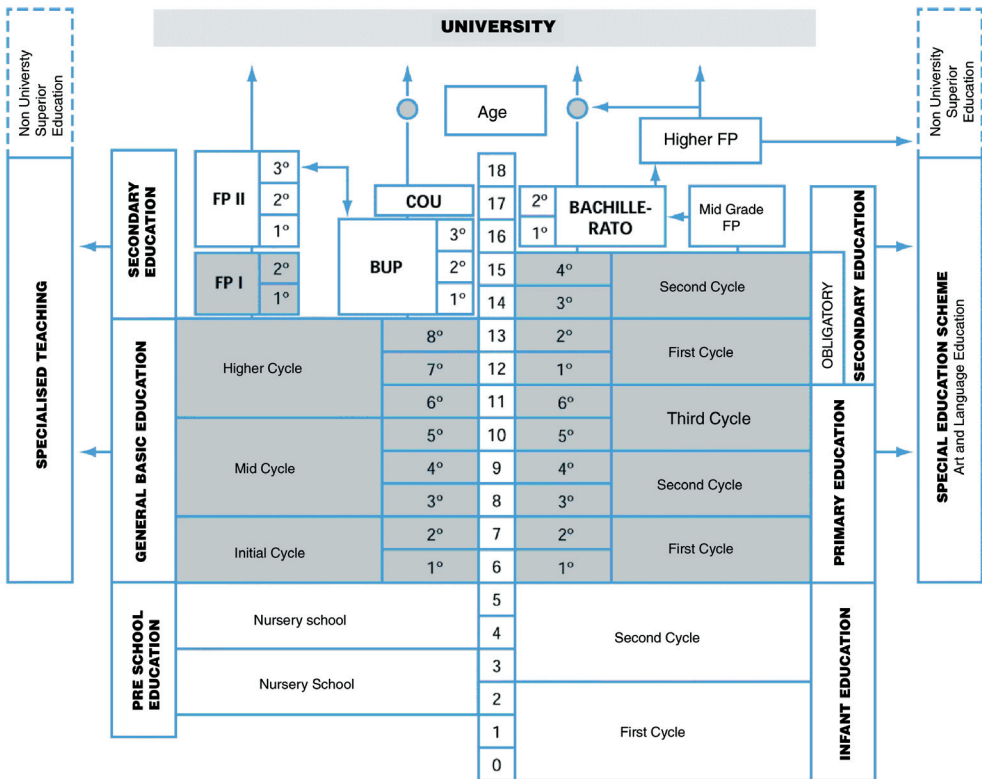

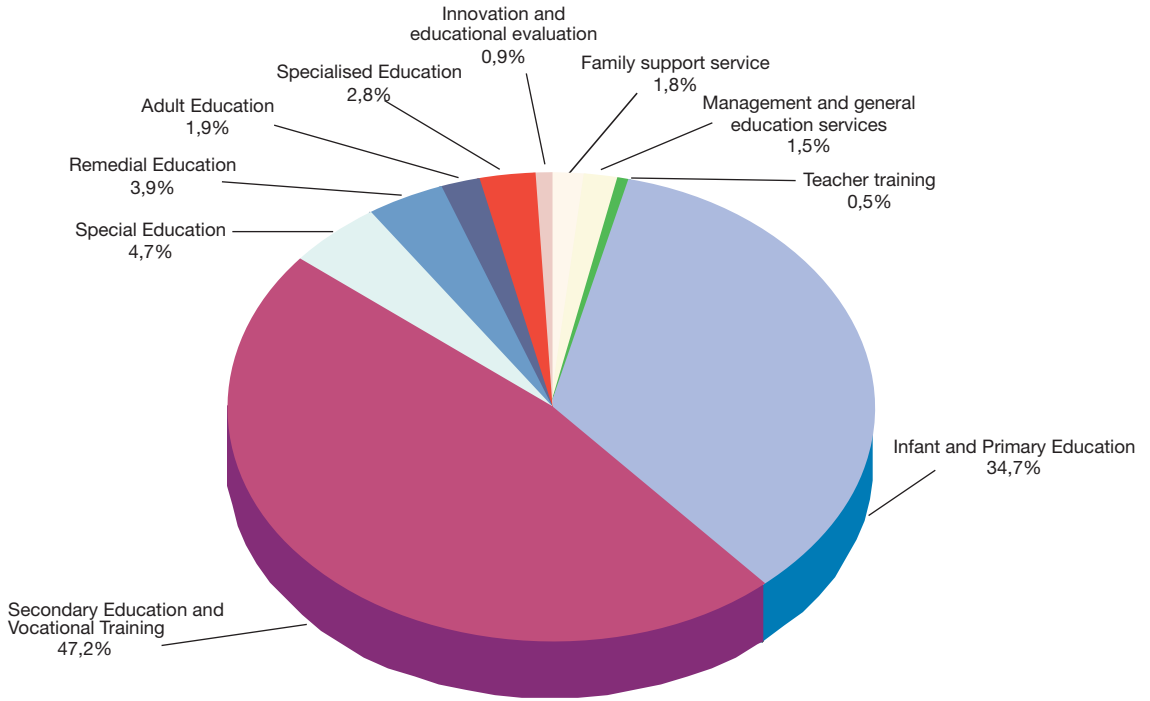

Labour Force Survey (EPA). INE. Elaborated by the National Institute of Statistics (INE) since 1964, it is a sample survey and not an exhaustive study, whose regularity - which has been periodically modified - is, at present, quarterly.

Its purpose is to provide information on the labour market: composition and evolution of the number of economically active, employed, unemployed and inactive persons according to different classification criteria, such as gender, age, economic sector, profession and other relevant aspects. At the same time, this information is available by different levels of spatial aggregation: Spain, Autonomous Communities and provinces.

The survey is focused on households; it has a sample size of 64.000 houses, implying coverage of approximately 200.000 people.

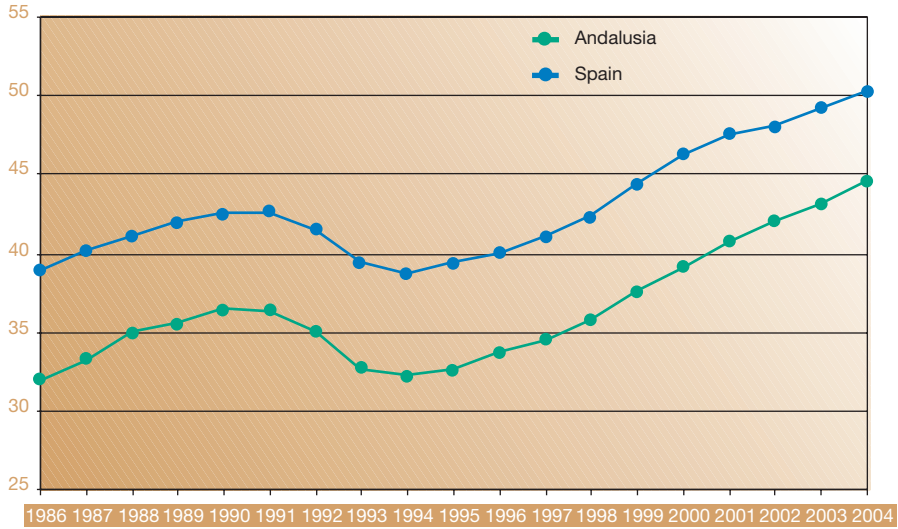
In 2005 the EPA has been modified for various reasons:

- Adaptation to the new demographic and labour reality, due especially to the rise in the number of resident foreigners.
- New Eurostat regulations rules.
- Improvements in data collection methods.

The implementation of these modifications generates changes in the population series¹. The INE web site offers detailed information on these changes, their repercussions, as well as retrospective data.

4.3. Evolution of employment rates. 1986-2004^{ab}

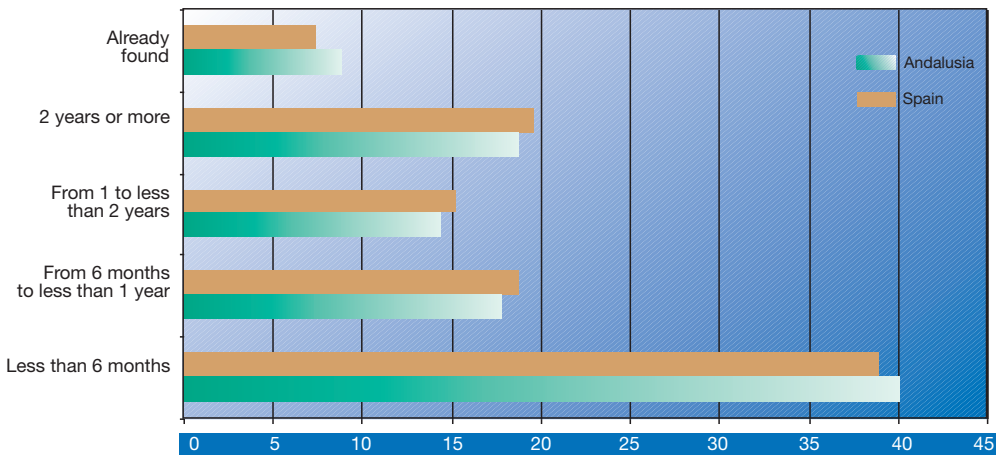

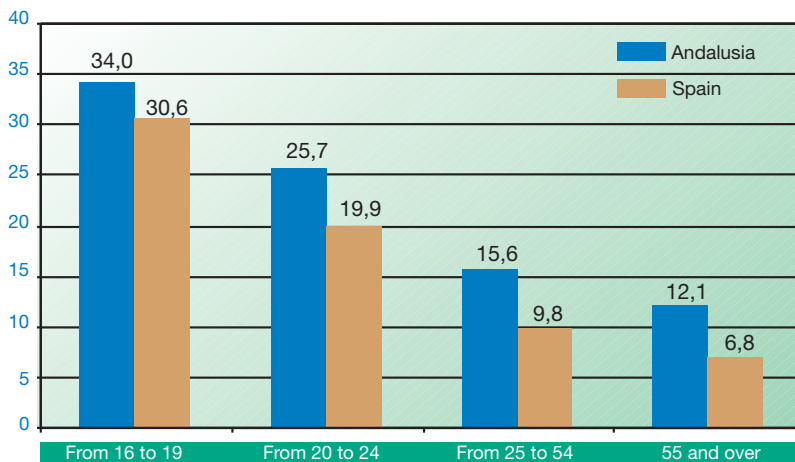
4.4. Unemployed population according to time spent job searching. 2004* (percentage)

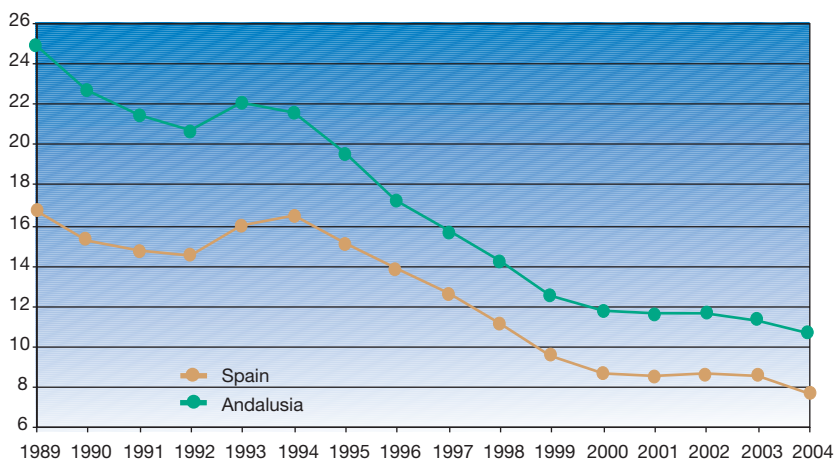

Quarterly labour costs survey. This is a continuous quarterly statistical operation, elaborated by the INE, a component part of the euro indicators that Eurostat has requested of the EU Member States to measure the convergence in labour costs. It aims to know the level and evolution of the labour costs. It includes not only salary costs but also other costs, costs by worker and hour worked. This survey enables the time worked and not worked to be monitored obtaining estimates of the average workday.

The population scope is made up of all salaried workers with contributions to social insurance schemes, regardless of their size, included in the General Regime of the Social Security and in the Special Regime for Mining and Coal.

Until the 4th quarter of 2003 this survey was denominated Labour Cost Index. From the 1st quarter of 2004 it became the Quarterly Labour Cost Survey.

Its basic object is to acquire the knowledge of the annual levels on average labour costs by worker, detailing its main components: wages costs, compulsory contributions to the Social Security, voluntary contributions and direct social benefits, dismissal pay, professional training expenses, transport expenses, other expenses and subsidies.

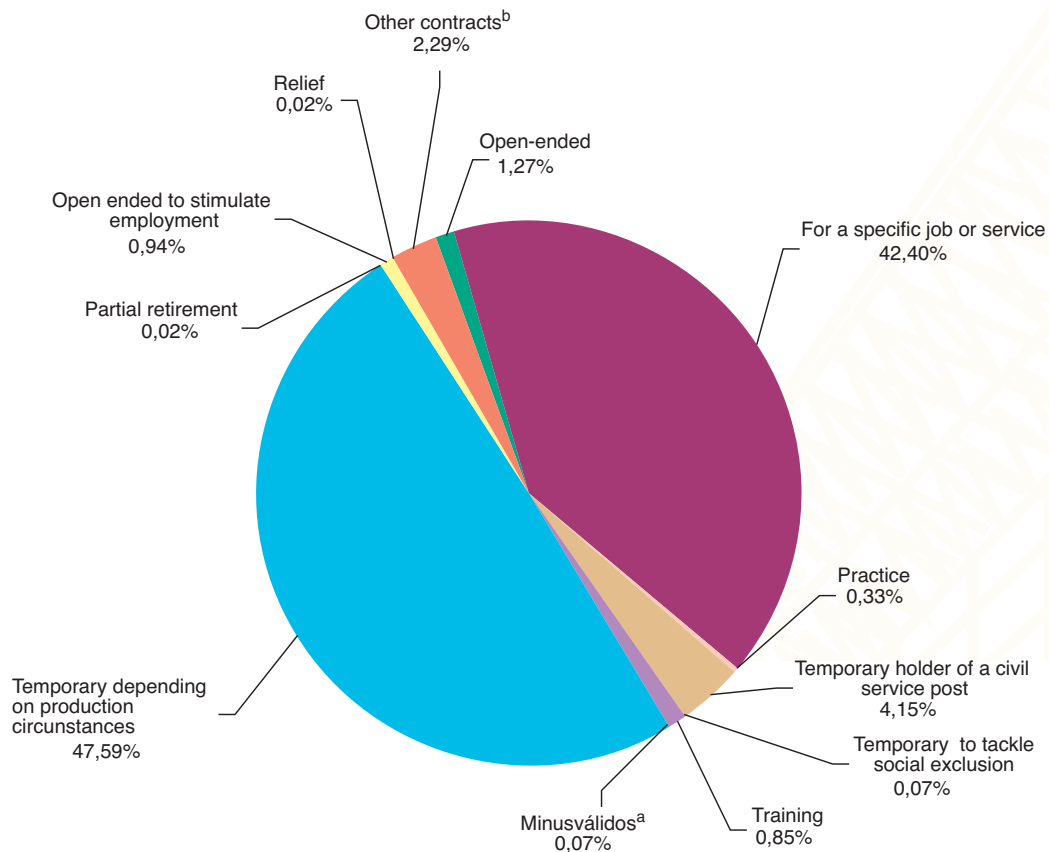

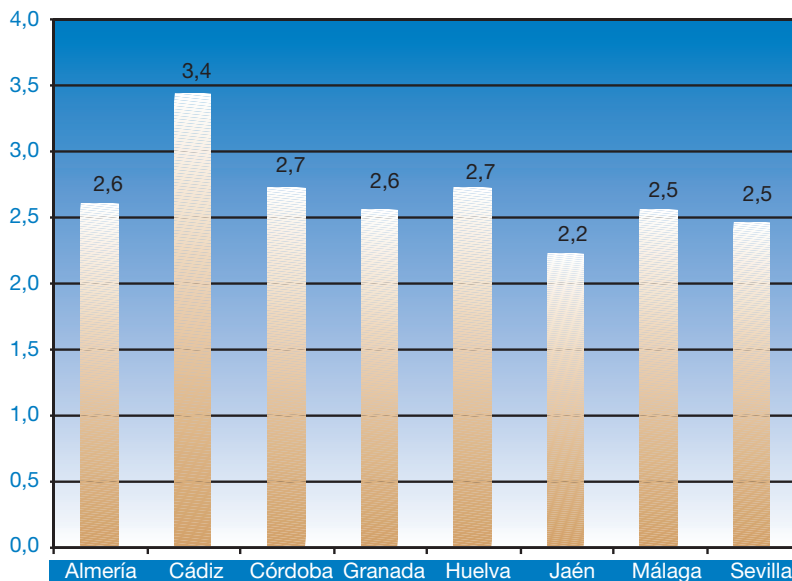

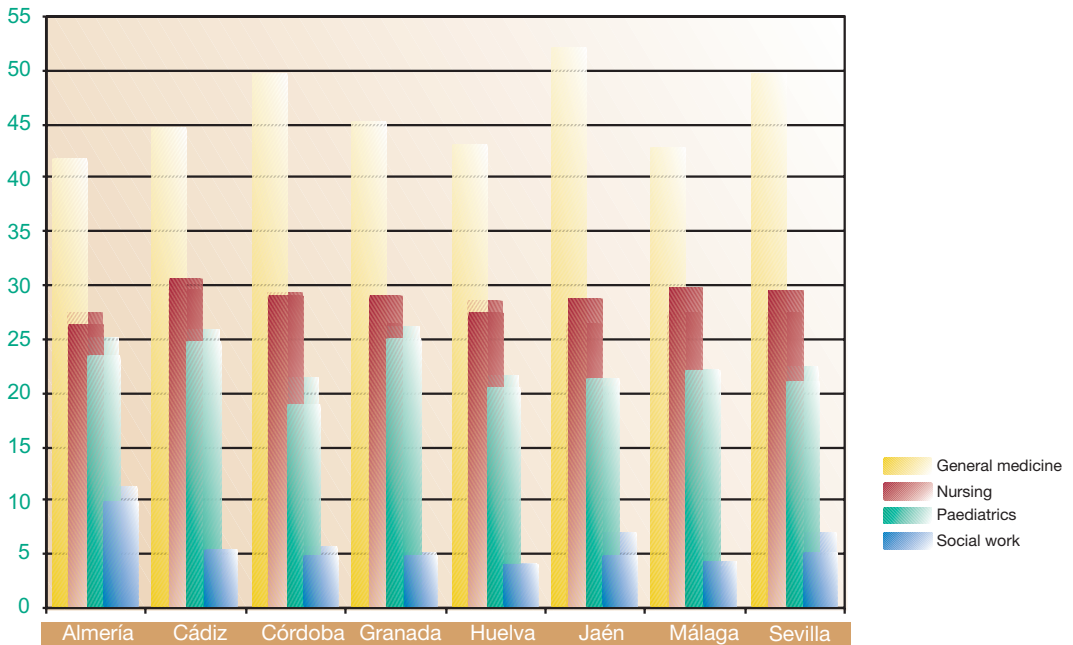

Sanitary resources and their distribution. The statistics that provide information on sanitary resources come basically from the Regional Government Ministry of Health and the Andalusian Health Service, contributing information on two levels:

- Primary Care: it is the first level of health care carried out in health centres, doctor's surgeries and other centres. The primary care integrates the preventive, curative,

and rehabilitation care and health promotion. The information that is offered in this area refers mainly to public centres and services and makes up the Statistics on Health Care Activity in Primary Care in Andalusia, compiled by the Andalusian Health Service. Its main source of information is the Information System for the Management of Primary Care (SIGAP).

• **Specialist Care:** it offers the means for diagnosis, treatment and rehabilitation that, for their specialisation or characteristics, cannot be solved at primary care level; it includes clinics, outpatient departments and hospitals. The information gathered in this area may refer to public as well as private centres, depending on the source studied. Thus, data from the *Catalogue of Andalusian Hospitals*,

elaborated by the Regional Government Ministry of Health can be offered, in which the basic features of all the Andalusian public and private hospitals are included. On the other hand, if the source employed comes from the Andalusian Health Service (Statistics on Andalusian Specialist Care Activities), more detailed information on hospitals that make up the public network is provided.

The information herein refers to primary or specialist care to which it is possible to add the information supplied by the Statistics on Health Establishments Providing Inpatient Care of Andalusia (EESRI), elaborated by the Regional Government Ministry of Health as well as by the Statistics on Basic Hospital Data of Andalusia (CMBDA), exploitation of the information provided in the Minimum Basic Data Set of the Andalusian Health Service.

These statistical activities, together with the abovementioned Statistics on Andalusian Specialist Care

Activities of the Andalusian Health Service offer detailed information on the entire hospital process, as well as data relating to the activities carried out in non-structured surgeries in external outpatient clinics compiled by the information system of the appointment system.

Furthermore, other specific sources provide information on pharmaceutical benefits and the utilisation of specific centres and sanitary services whether in infant vaccinations, organ transplants, blood donation, abortions, etc.

Its essential objectives are the following:

a) To evaluate the Spanish agriculture situation and to follow the structural evolution of the farms as well as to obtain comparable results among all the Member States of the European Union.

b) To fulfil the legal guidelines laid down by the European Union in the different Council Regulations (Regulation 2467/96 establish the compulsory taking of a census between December 1st 1998 and March 1st 2001 and sampling surveys on the agricultural campaigns of 2003, 2005 and 2007), as well as to meet the national statistical requirements and other international requisitions for statistical information on the agrarian sector.

The research is carried out in the whole national territory, and refers to the agricultural campaign of October 1st 2002 to September 30th 2003, considered the reference year. Publishing national and autonomous community results on area used for farming (farm size, crop type, holding regime, livestock, irrigated land, family and salaried work...) and on technical-economic features (economic dimension, gross profit, main tendency ...)

Overall this new survey upholds the framework of the last censuses and surveys to facilitate the study of the agricultural evolution and data comparability.

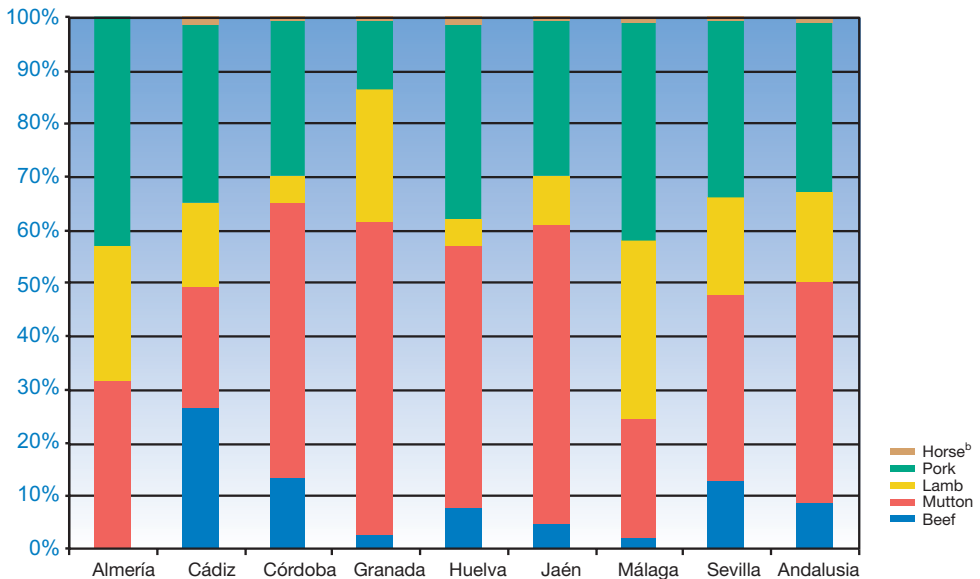

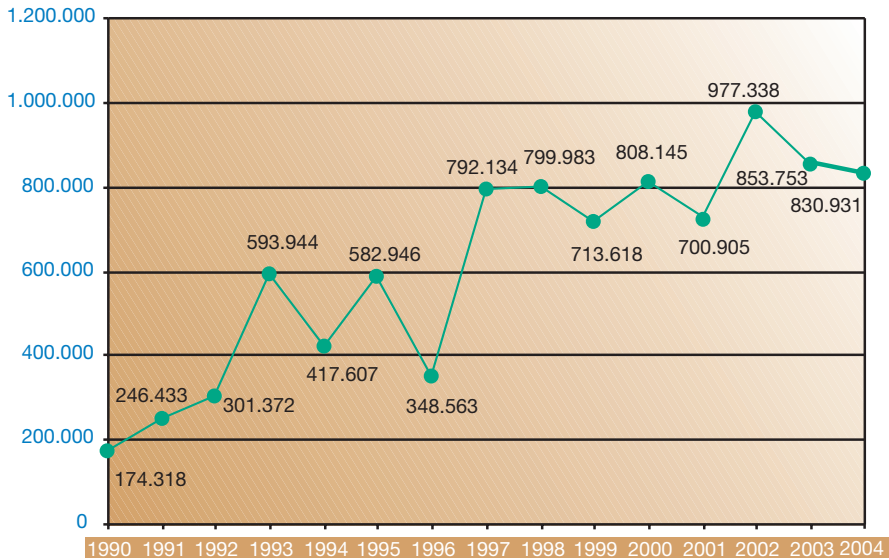

Agrarian and Fisheries Statistics Yearbook. Regional Government Ministry of Agriculture and Fisheries. It is a compendium of Andalusian agrarian and fisheries sector statistics, for the reference year. Its main purpose is the structured dissemination of information of interest relating to the agricultural, forestry, livestock and fishing sub-sectors in Andalusia. The information comes mainly from

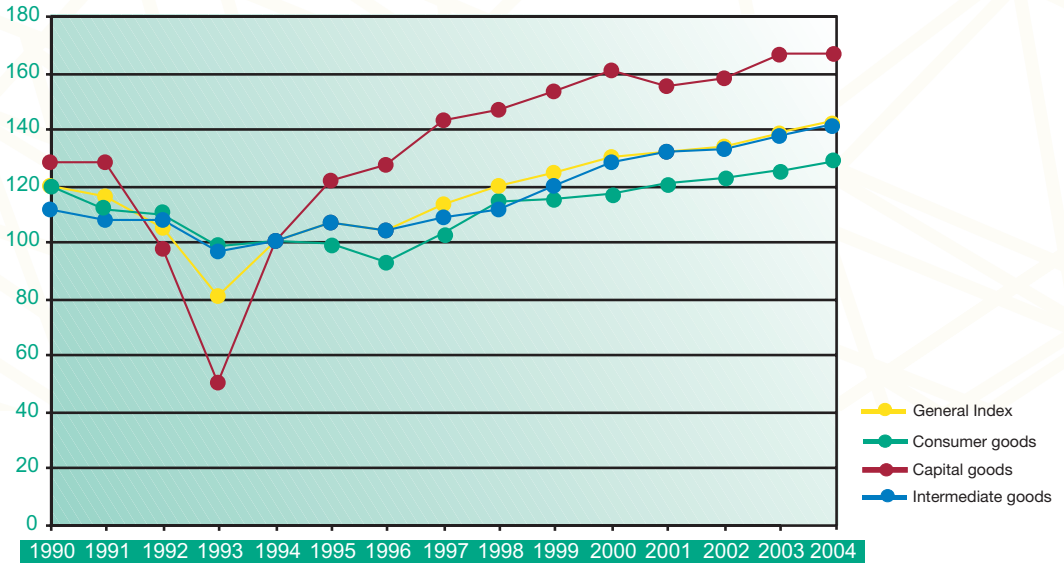

Industrial Production Index of Andalusia (IPIAN). IEA. The IPIAN is a Gross Value Added (VAB) indicator for the Andalusian industrial sector aimed at measuring the short-term evolution, specifically on a monthly basis, elaborated by the Institute of Statistics of Andalusia. The implementation scope of the IPIAN is the economic sector of the Autonomous Community of Andalusia. The ascription of an industrial activity to this sector does not

depend on the legal basis of the company and whether it is linked or not to other organisations outside the region. The main factor identifying a production unit as pertaining to the industrial sector of the Autonomous Community of Andalusia is the maintenance of an establishment or permanent work centre in which activities integrated in the industrial sector are developed.

Industrial Survey of Companies and Industrial Survey of Products. INE. These surveys are a follow up of the no longer existing *Industrial Survey* and they make a full analysis of the activity of the industrial sector possible. In Andalusia, the IEA presents the same publications in greater detail for the Autonomous Community named *Annual Industrial Survey of Companies. Data for Andalusia* and *Annual Industrial Survey of Products. Data for Andalusia*.

The main purpose of these annual surveys is to provide information relating to the chief characteristics of the diverse sectors that make up the industrial activity of the economy, not only with respect to the employment they generate but also to their operating, investment and production expenses. The goal is, in this way, to satisfy

national and international information requirements on this subject.

The designation change of these publications, initiated in 1993, came about through the commitment to adapt to the Regulation PRODCOM (PRODUccion COMunitaria - COMMunity Production) - relating to the harmonisation of the industrial production characteristics in European Union countries - and it fulfils Eurostat recommendations, the European official statistical organism. The fundamental difference with respect to the previous *Industrial Survey* is that now the survey unit is the company for the *Industrial Survey of Companies* and the establishment for the *Industrial Survey of Products*.

Annual industrial survey of companies. Data for Andalusia. IEA. This is a statistical activity that adapts data from the Industrial Survey of Companies of the INE in greater detail for the Autonomous Community of Andalusia encompassing the companies main characteristics on employment, time worked, revenues and exploitation costs and other variables of interest, all classified according to activity branch.

The Autonomous Community of Andalusia breakdown tries to respect to the maximum that of the INE, although it has not been entirely possible because for some of the 100 industrial sectors studied (maximum breakdown level) the sample used was not representative for Andalusia. For these reasons some of the sectors have been grouped together in the most consistent way possible.

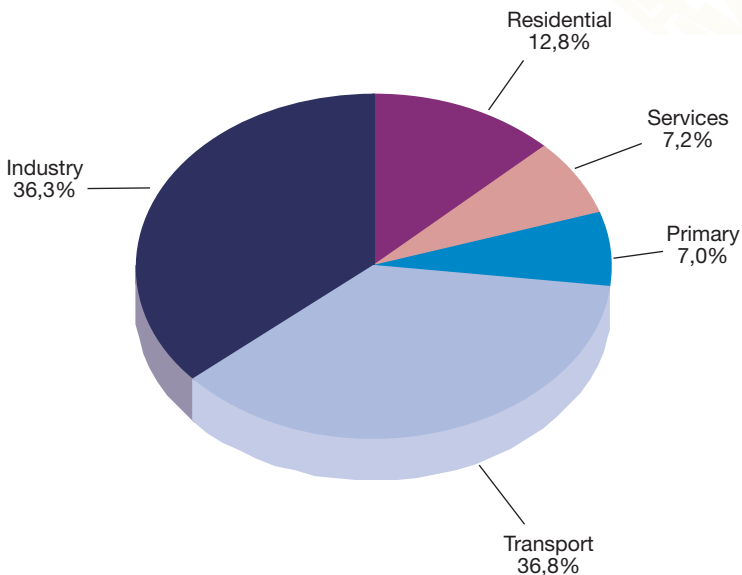

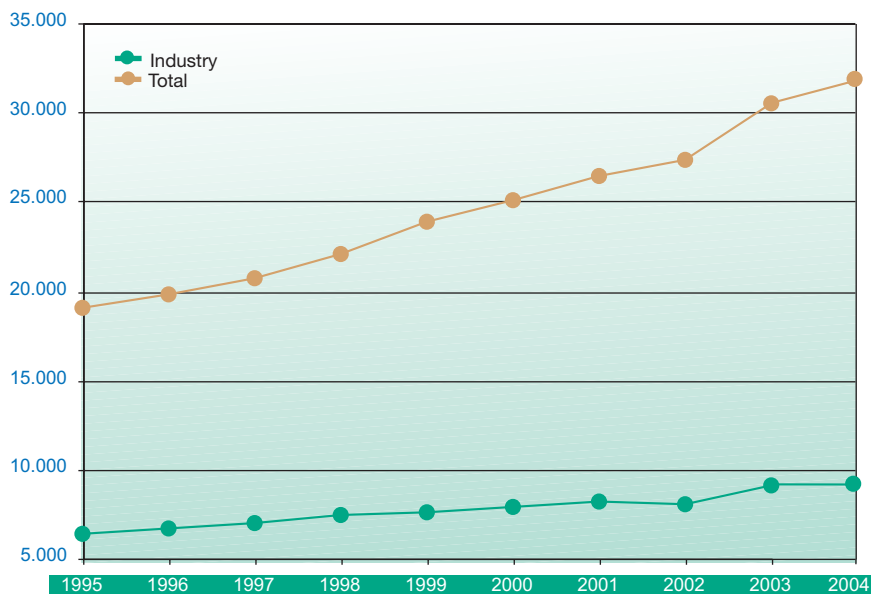
7.4. Structure of final energy consumption by activity sector in Andalusia. 2000-2003 (ktep)

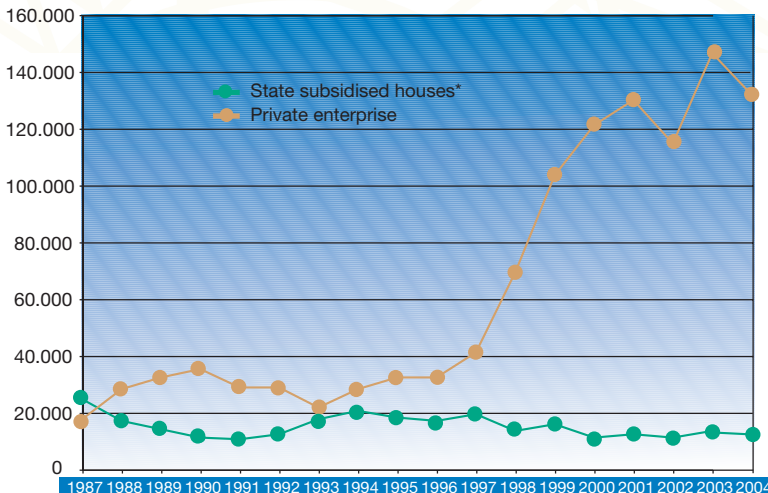

8.2. Evolution of houses under construction according to housing regime in Andalusia. 1987-2004

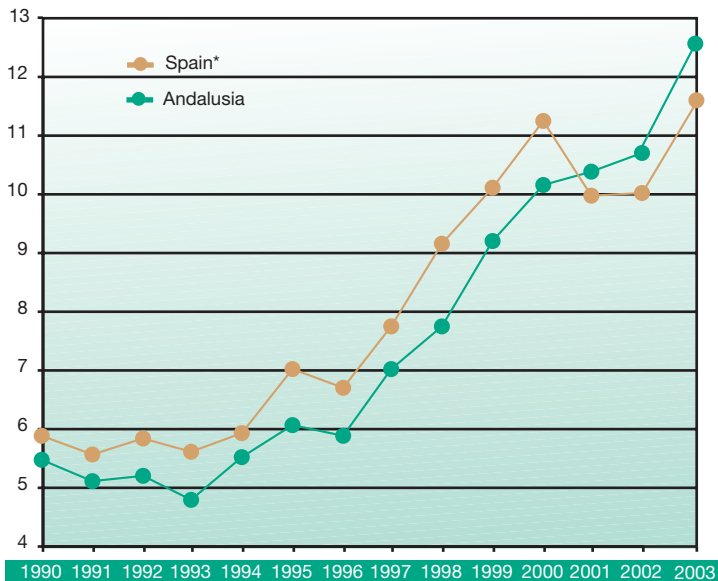

Ministry of Public Works This monthly statistics has been made since 1991 from the questionnaire the promoter or technician responsible for a project must submit to the Town Hall when soliciting the license for building work, demolition and renovation of buildings and houses. It offers information mainly on the following variables: general features of the building work (location, legal basis, type of promoter, estimated duration); estimates of building materials; number

and characteristics of the buildings (purpose, surface area and volume, n^o of storeys, building type and facilities); number and characteristics of the houses (total living space, n^o of rooms and bathrooms and type of finish). Data are broken down at Autonomous Community level and exploitation of municipal data (individualised for those of more than 10.000 inhabitants and aggregates for those of a lesser size) are also elaborated.

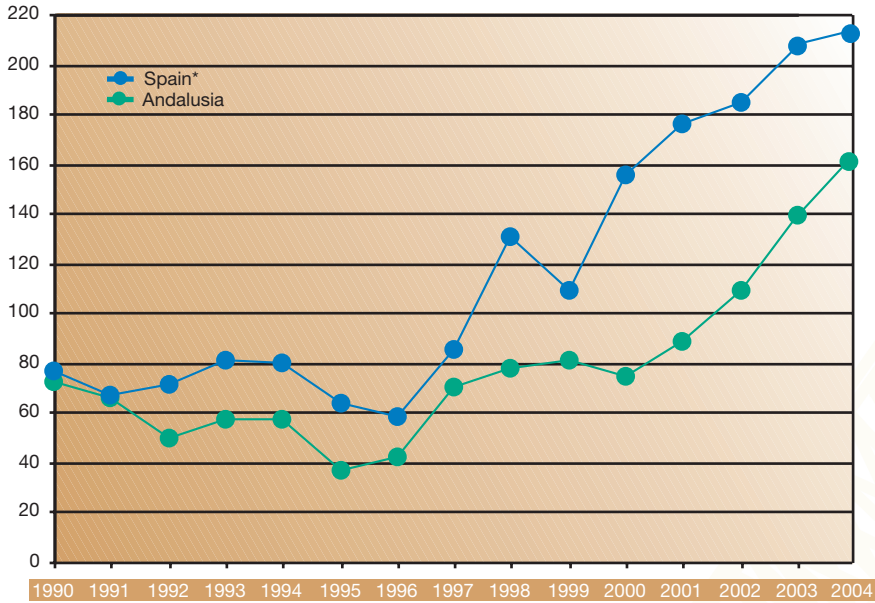

The quarterly Statistics on the Average House Price per sq m is elaborated through mortgage valuation, information provided by the valuation societies aimed at providing the evolution of house prices. Given the number of valuations used and their geographic distribution, they are an indicator of enormous interest of

the real estate market. The geographic scope is the national territory, except the cities of Ceuta and Melilla. Information is offered on the following variables: valuation date, total square footage, and valuation price, year of construction, postcode and municipal code.

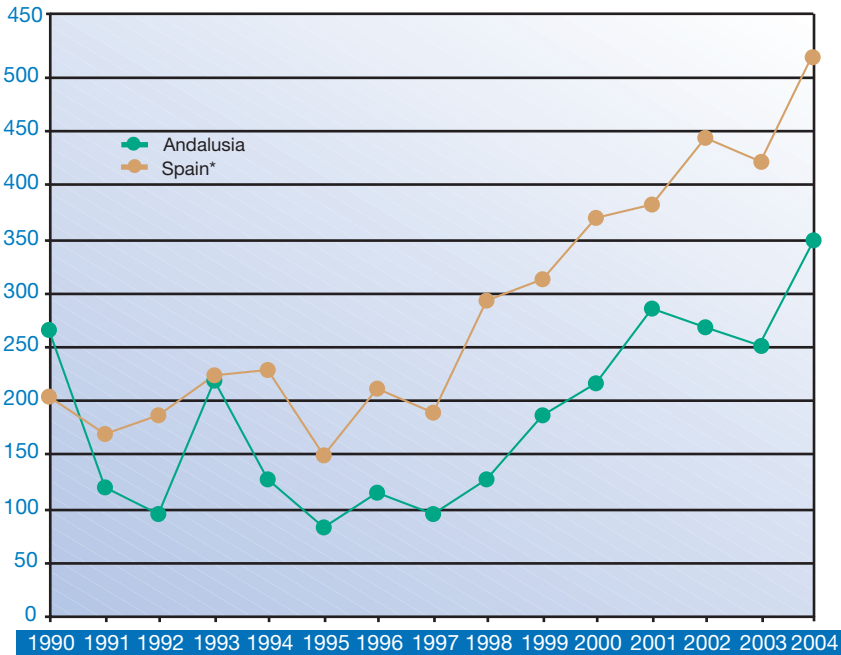

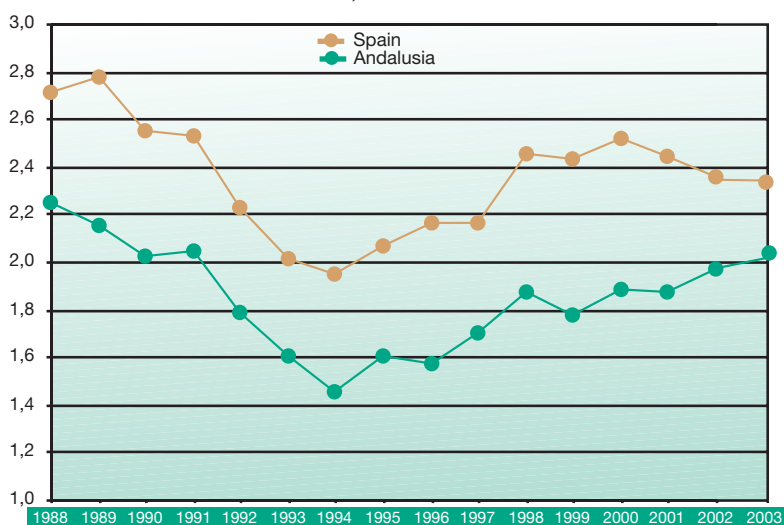

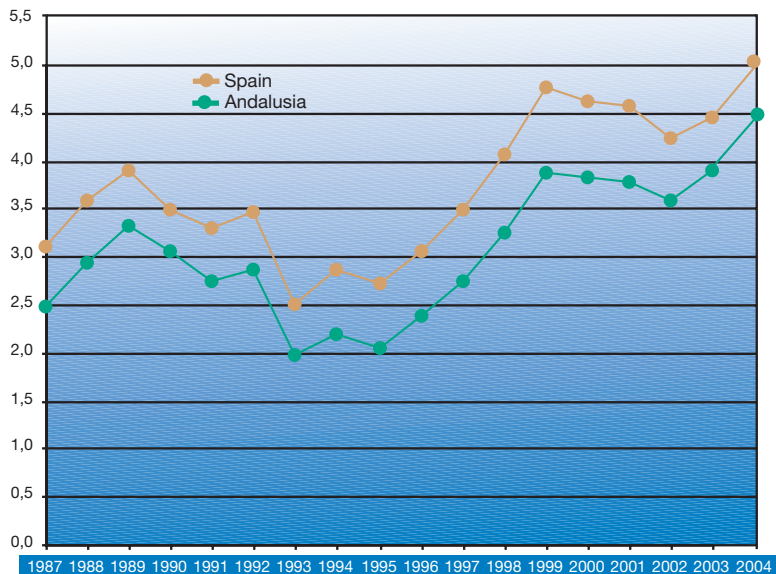

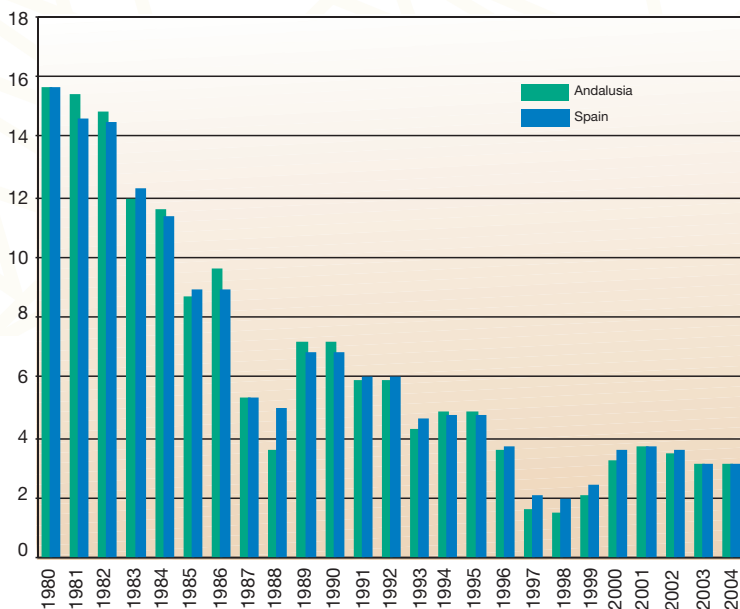

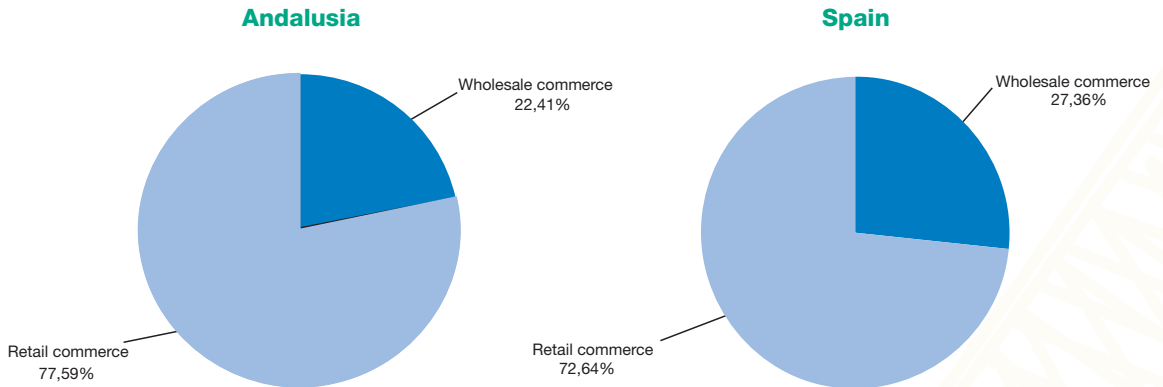

activity carried out by the establishments, coming from registers and statistical files, rounded off with information from the INE. It is aimed mainly at setting up a framework to design sub-populations for survey elaboration and to provide a source to develop structural statistics on companies.

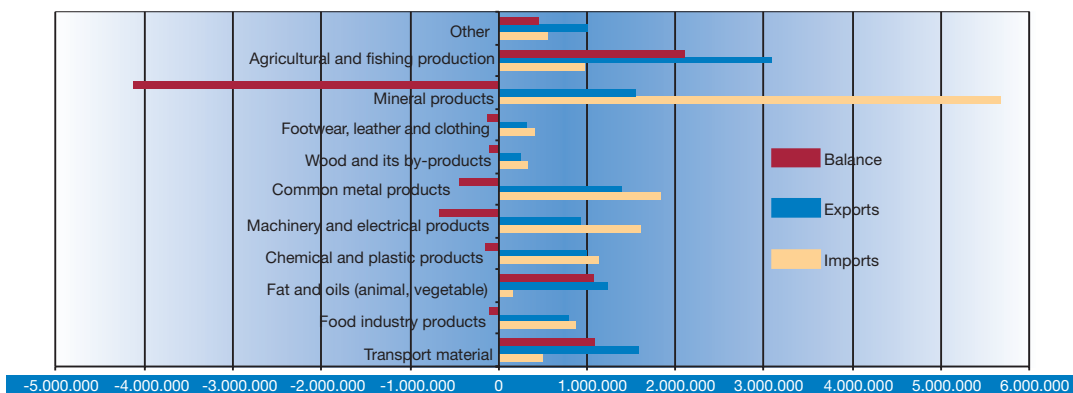

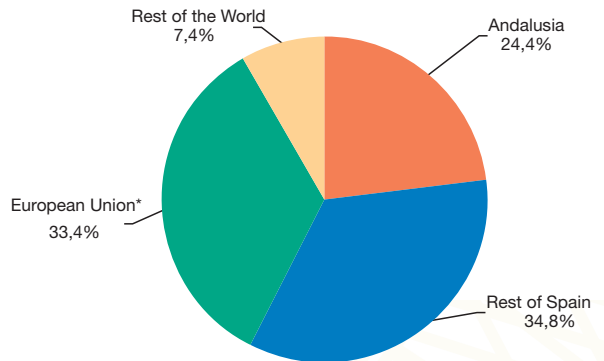

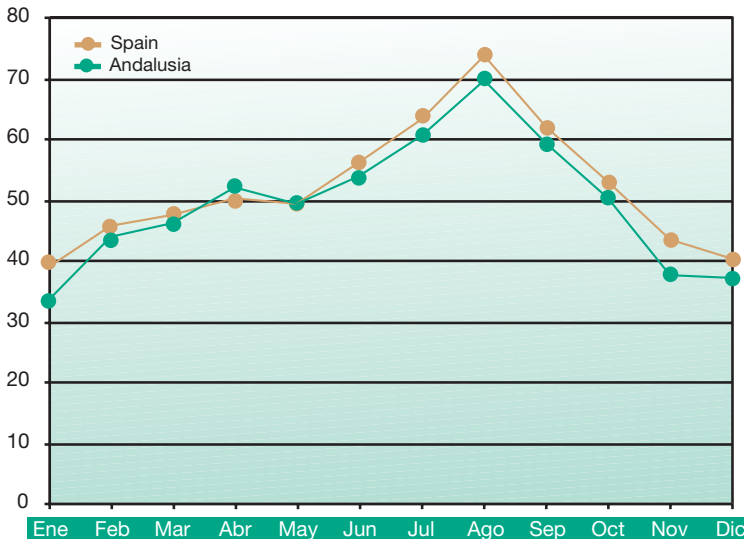

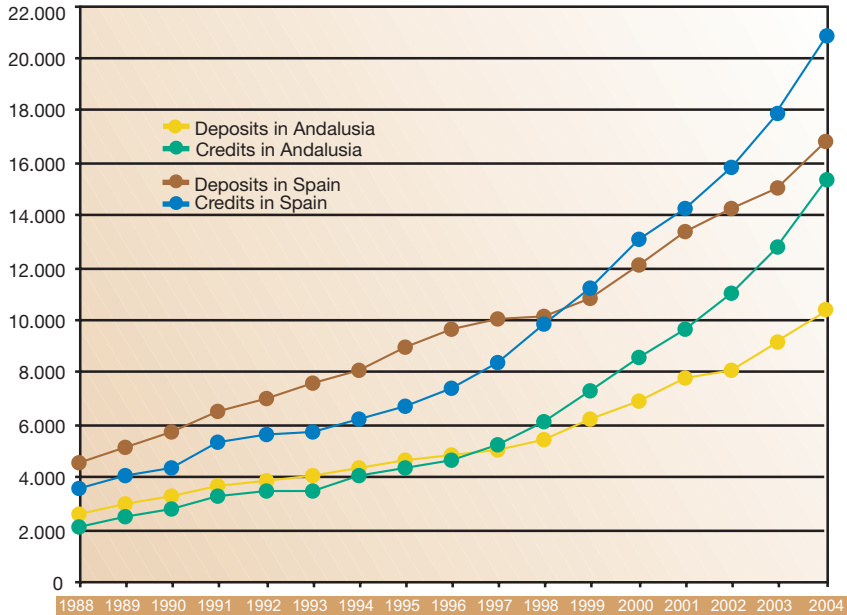

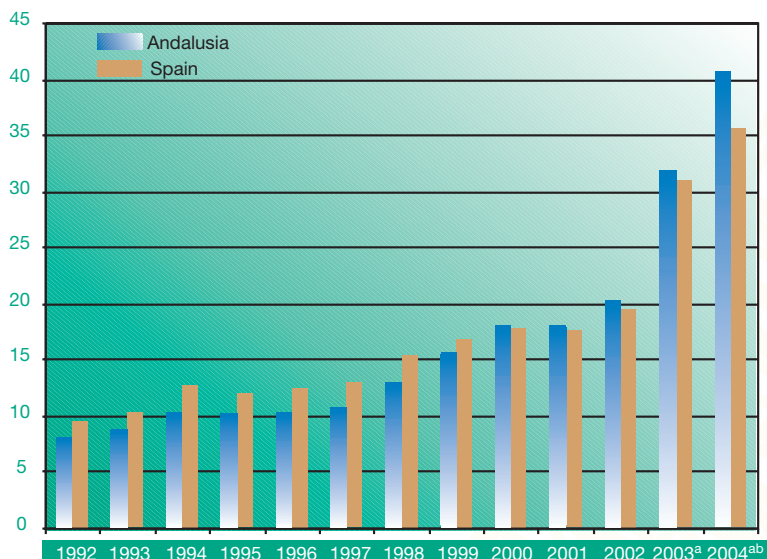

11.4. Evolution of the number of urban property mortgages. 1992-2004 (number of mortgages/1000 inhabitants)

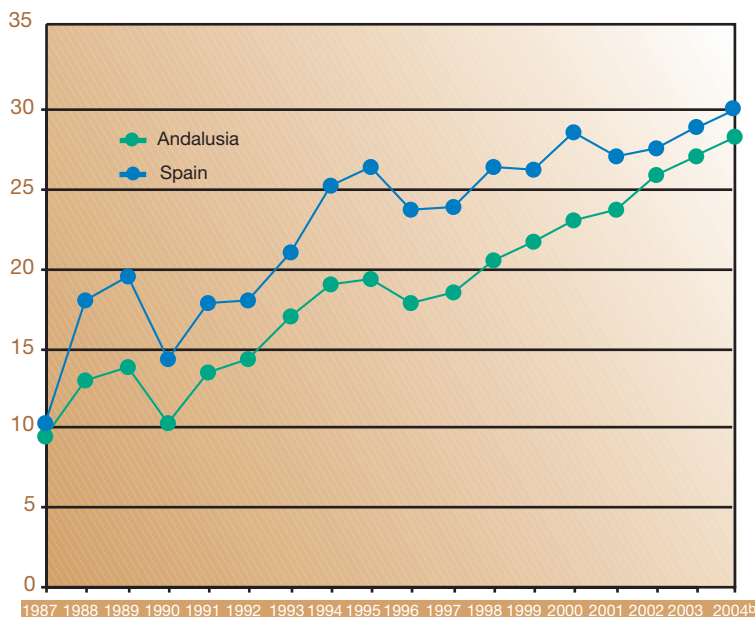

11.5. Evolution of the creation of trading companies^a. 1987-2004 (trading companies created/10000 inhabitants)

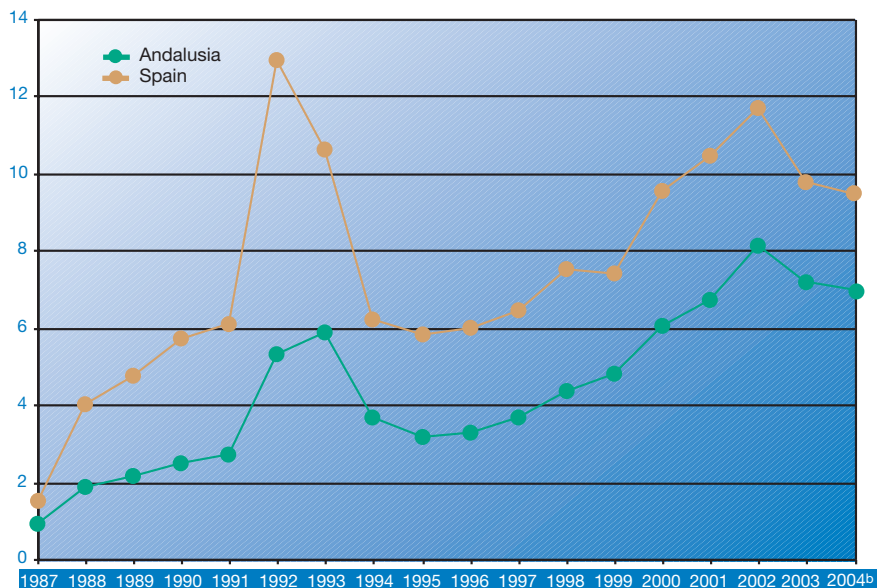

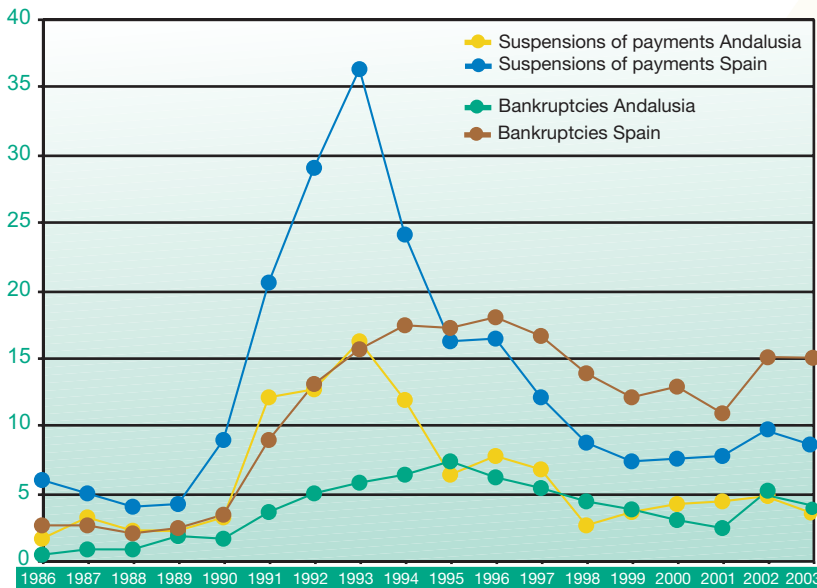

Receivership: traders or companies that, possessing enough resources to cover their debts, foresee the impossibility of settling them at due date owing to cash flow problems, lack of demand, low productivity and other reasons may ask for receivership.

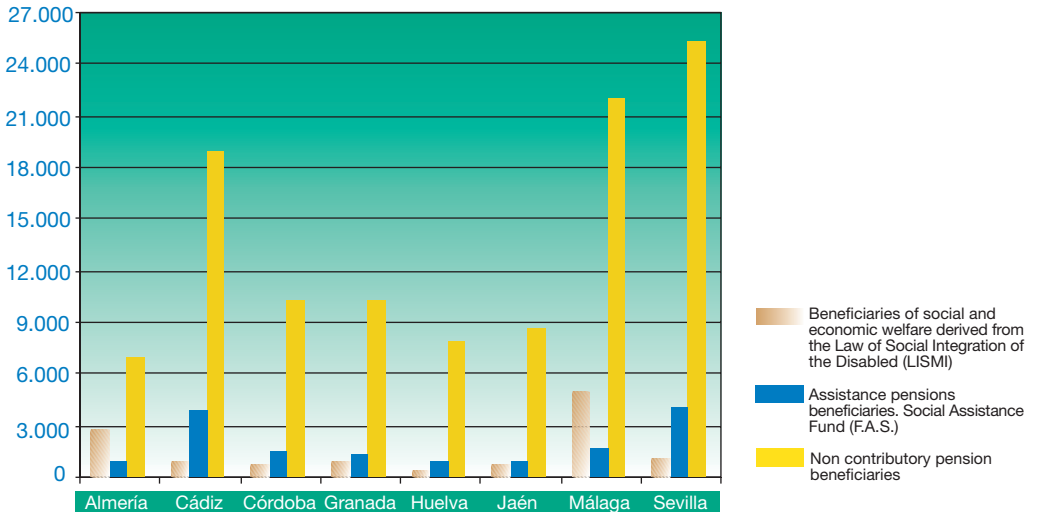

Foster families: social protection measure put forward for minor in specific circumstances by which he/she is temporarily introduced into a family which is not made up by his natural parents. This situation will last until the minor can be reinstated in its origin family, or to be reinstated in his/her social environment when he/she is old enough to reach his/her own emancipation or until the minor can be adopted. The foster family may receive an economic compensation and there is not any familial parental bond.

Adoption: legal measure by which a minor is definitely introduced into a family which is not made up by his natural parents, with the same consideration, respect, rights and duties as the natural children. The adopting family takes on all the patria potestas duties, disappearing, except in extraordinary cases, all links between the minor and his natural parents

Beneficiaries of non-contributory retirement pensions: Persons of sixty-five and over without adequate resources are entitled to this type of pension, although they have never paid contributions or not sufficiently. They must have resided between the date of their 16th birthday and the date of claiming the pension in Spanish territory or in a European Union country for ten years of which two must have been consecutive and immediately prior to claiming the benefits.

Beneficiaries of non-contributory disability pensions: Persons entitled to this type of pension are those between eighteen and sixty five with a disability or chronic illness of 65% or over; people who want to obtain the economic complement of 50% for third person's help having a disability or chronic illness of 75% and over and exceed the established scale. They must reside in Spanish territory and must have been living in Spain or in a European Union country for five years of which two must have been consecutive and immediately prior to claiming the benefits.

Benefits from the Law of Social Integration of the Disabled (LISMI): these benefits are aimed at providing disabled people with the essential means for the exercise of their rights, and to guarantee the minimum economic, legal and social resources.

Benefits for illness/old age from the Social Protection Fund (F.A.S.): these benefits apply to people whose personal or family revenues are inadequate to cover their basic needs.

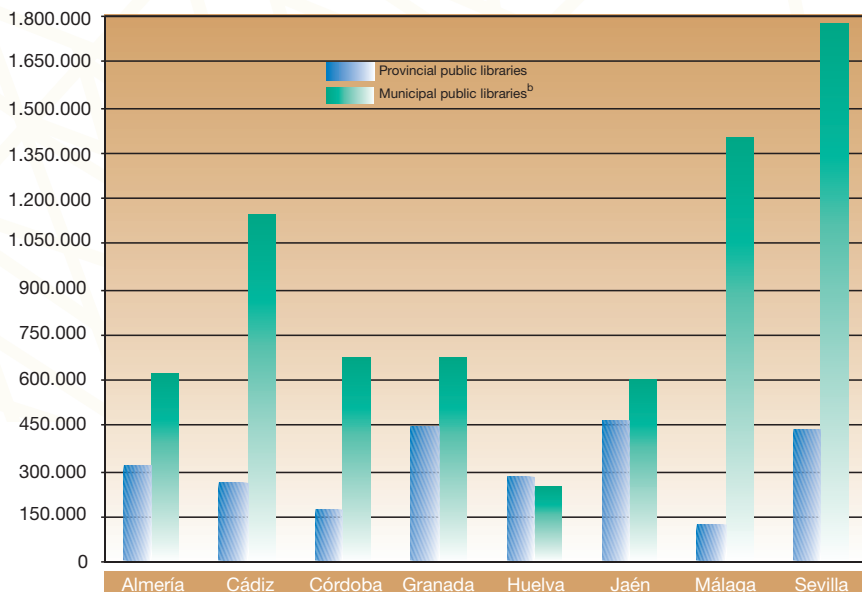

Library Statistics. INE. Its goal is to compile information on the number of the existing libraries and service points in Spain, as well as their collections and operations, resources, workforce, activity and expenditure. This study is carried out by type of library and by autonomous community and province.

This statistics is made biennially and its scope extends to all the libraries in the Spanish territory, whatever their

administrative dependency, except the private ones not open to the public. The information applies to the natural year, although some features refer to 31 of December of the year the study was conducted.

The INE has made this statistics since 1960. However, it was reorganized in 1972 to adapt to UNESCO recommendations in the 1970 conference.

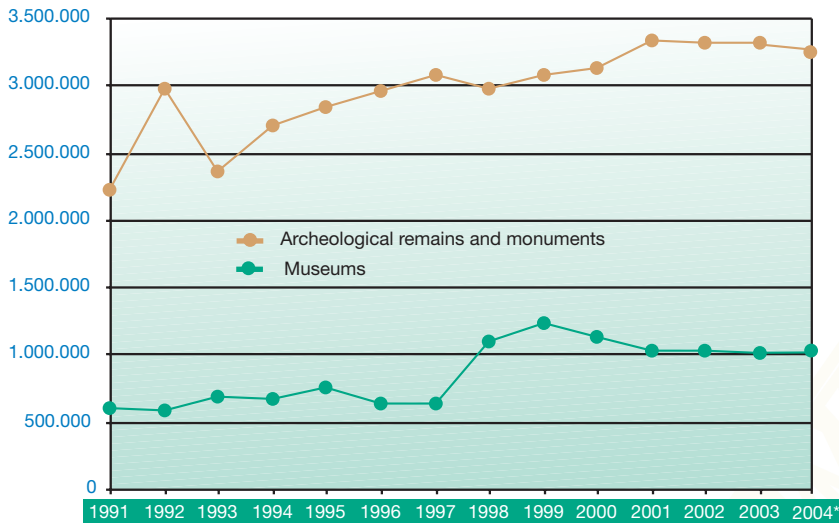

Machines type B: recreational machines that, in return for the price of the game, give the users a time to play and, eventually, a prize whose value cannot exceed twenty times the price of the game. This type of instrument must return at least 75% of the bets carried out.

Television Audience Yearbook. SOFRES, Media Audience. It provides data and expressive analysis on television audience tendencies. To this end it measures and monitors the television audience through the audiometers provided to a representative panel of homes.

The panel is made up of primary residences with television in the Peninsula, the Balearic and Canary Islands

and all the individuals aged 4 and over living there. The regional sample is not proportional because in some communities with autonomous television it has been oversized in order to guarantee satisfactory sample for studies that include percentage wise reduced variables. At the moment, panels exist in more than 3.305 homes.

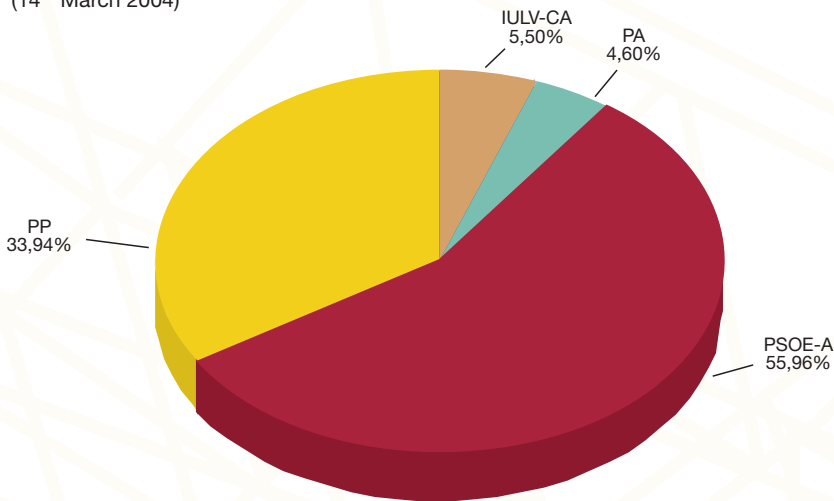

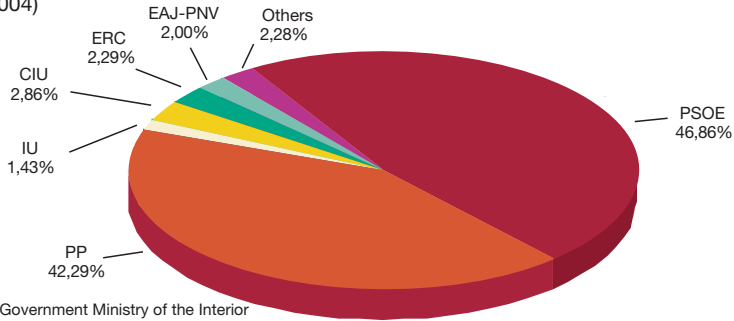

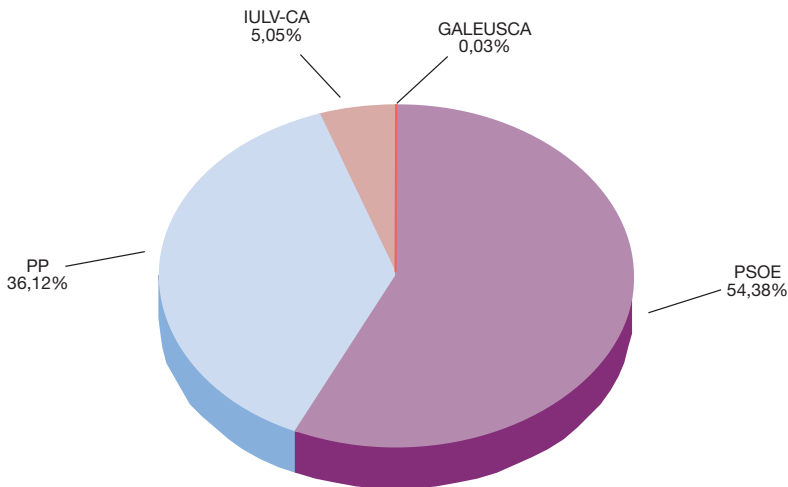

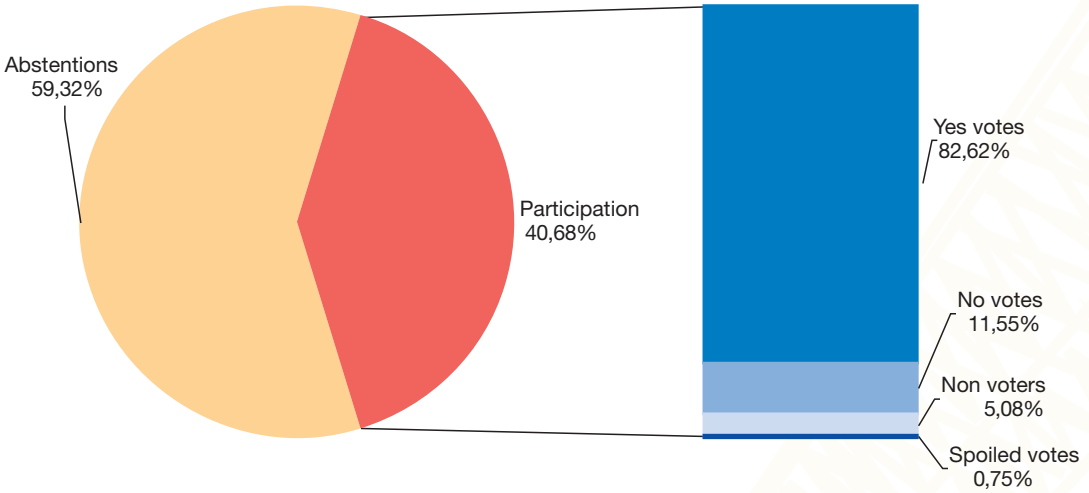

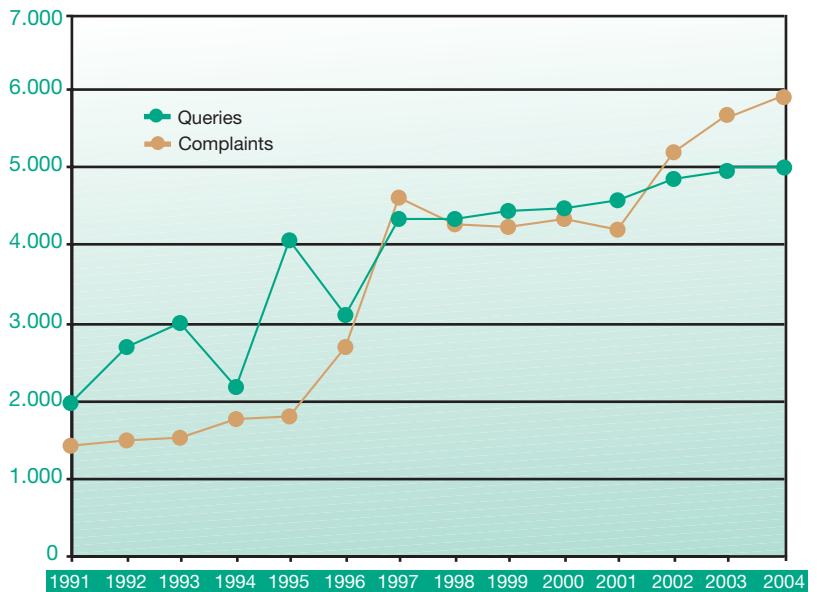

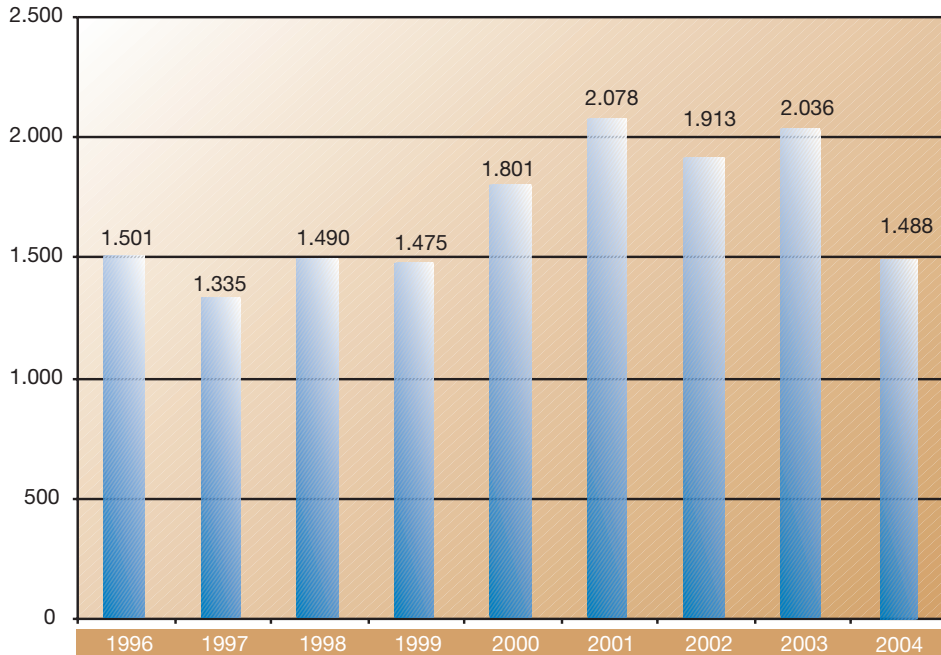
6.6. Evolution of the queries and complaints made to the Andalusian Ombudsman. 1991-2004

The great numbers of the Andalusian economy

This chapter refers to the evolution of the great regional numbers (economic macro-magnitudes): the gross domestic product, the gross value added, the remuneration of wage-earners and gross operating surplus/mixed income, coming from the annual and Quarterly Regional Accounting of Andalusia and from the Regional Accounting of Spain.

It also gathers data on provincial distribution of the gross value added.

Likewise, the macroeconomic picture of Andalusia for 2001 is included, presenting the different components of the gross domestic product at market prices based on demand, supply and income generation.

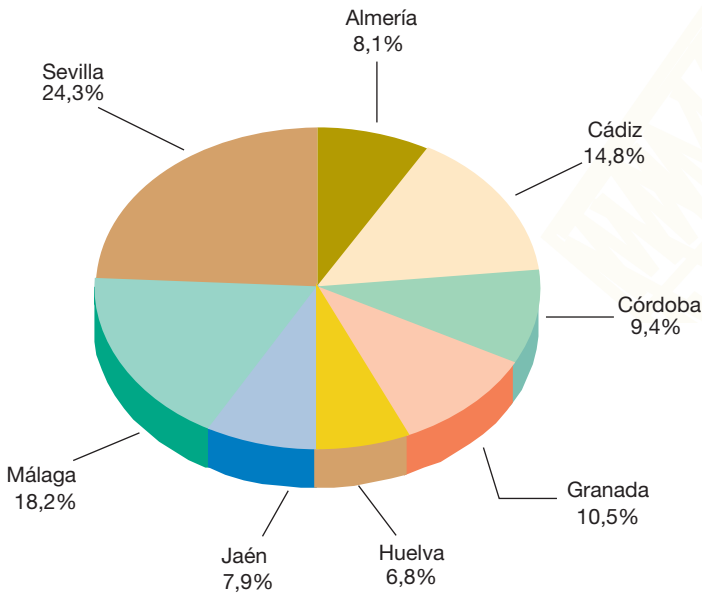

it has changed the base year to 1995. This publication is integrated in the European System of Accounts (SEC) and uses the definitions and standards established by this system.

Annual regional accounting of Andalusia. Base 1995. Series 1995-2001. IEA. The elaboration of the System of Economic Accounting of Andalusia begins with the Input-Output framework referring to 1995 (MIOAN-95). This system integrates the Annual Regional Accounting of Andalusia whose objective is to know the main economic

magnitudes of the different branches of activity in Andalusia and their evolution, as well as to allow the comparison of results with those obtained in other territorial areas.

This study adopts the new European System of National and Regional Accounting (SEC-95) methodology, in force in the European Union.

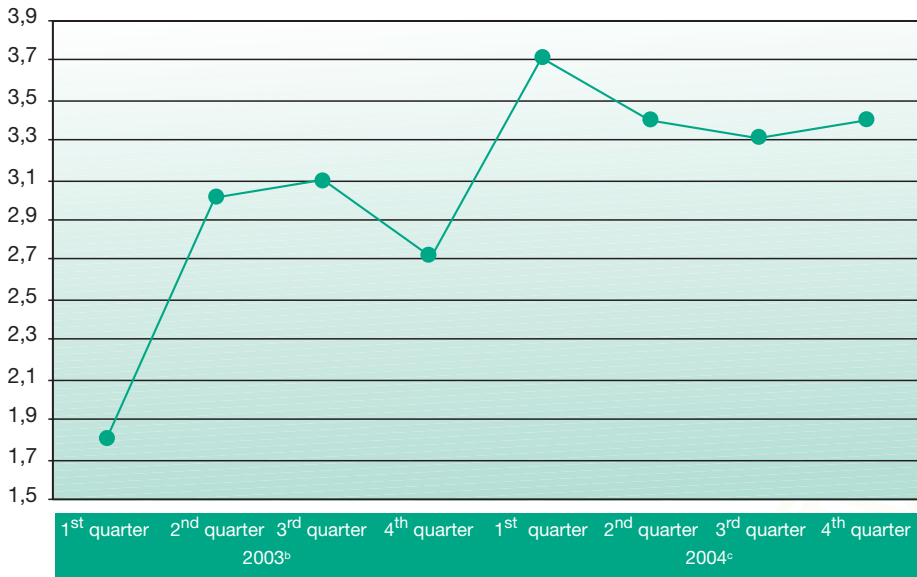
